Dear Parent/Guardian,

Our Parent Payment Policy and 2022 voluntary financial contribution information has been updated as directed by DET. For further information on the Department's Parent Payments Policy, see the one-page overview attached.

Orbost Secondary College is looking forward to another great year of teaching and learning and the ongoing support from our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that's through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Within our school this support has allowed us to maintain our canteen service, offer an instrumental program for Years 5 -12 across six local schools, provide extra education support staff in classrooms, purchase student blazers and sports tops and a myriad of other activities that enhance our school community.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all Curriculum Contributions and Other (non-curriculum) Contributions are voluntary.

Extra-Curricular Items and Activities

Extra-Curricular items and activities are provided on an opt-in or user pays basis and payment for these will be requested during the year. We ask that parents indicate which Extra-Curricular items you would be likely to purchase, so we can plan for viability and final costs of running these activities and return the form to the office by Friday 10th December 2021.

Refunds

Orbost Secondary College will consider requests for partial or full refunds of payments made by parents on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy, and any other relevant information.

Students leaving Orbost Secondary College

If a student transfers to another Victorian school, the unspent portion of any CSEF will be forwarded to the student's new school so the student has access to the full value of the payment.

If a student leaves the Victorian school system, any unused CSEF will remain with the school and may be used towards the expenses of siblings enrolled at the College, or if no siblings remain, be used for school incurred costs associated with operating camps, sports or excursion activities for students.

Credit amounts of parent payments (cash, direct deposit, Centrepay, BPay instalments) held at the time of the student leaving Orbost Secondary College may be used towards the expenses of siblings enrolled at the college or refunded back to the parent if no other siblings remain.

ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
